- 1. Retire from your government job on paper only
- 2. Collect a Salary and a Pension at the same time to to the same job
- 3. Don't pay the standard 3% of salary into the Retirement System
- 4. Cash out up to 500 hours of unused days off at final highest salary rather than salary when days off were earned artificially spiking up last year's pay which is what pension is based on
- 5. Collect a lump-sum pension bonus
- 6. Return to the same job and keep your Salary + Benefits + Pension Bonus



HOW THE DROP PENSION BONUS SYSTEM ABUSES TAXPAYERS



- Deferred Retirement Option Program (DROP)
- Allows retirees to collect pension payments and a salary at the same time to do the same job
- Payouts inflated by up to 500 hours of unused time off calculated at final highest salary, not salary when days off were earned

In 2020, there were 76 Collier County General Government Retired Triple Dippers receiving \$5.8 million in salaries and \$12 million in cash bonuses. As of January 2025, there are 86 retired Collier BOCC employees receiving a salary and \$19 million in pension cash bonuses and \$7.8 million in salaries at the same time to do the same job! Pension Cash Bonuses increasing Burden on Taxpayers and Crowding out Operational Funds. Give young men and women a chance to start a career, a family and buy a house instead of fattening the paychecks of overpaid, over the hill bureaucrats. It has been about 45 years since Triple Dippers earned a college degree or High School diploma or even no Diploma.

ELIGIBILITY FOR DROP TRIPLE DIPPERS

Enrolled before July 1, 2011, only **6** years of Government employment and age 57 after July 1, 2011, only eight years of government employment and 62 to vest, even part time and seasonal government workers!

Unfortunately, <u>yes</u>. Until we pressure our State Legislators and Governor to eliminate or Limit the Pension Cash Bonuses and require they pay 3% of salary into the FRS

DOES **TRIPLE DIPPING** MEET COLLIER COUNTY'S HARDWORKING CONSERVATIVE COMMUNITY STANDARDS?

No. The average Collier County resident makes \$46,573 or \$22 per hour would have to work 23.6 years to earn Collier County Triple Dipper King John Plummer's \$1,099,232 pension cash bonus and 2.6 years to make Plummer's annual salary of \$121,658.





CALL TO ACTION: REPLACE AND PRIVATIZE

Replace Triple Dippers with Private contractors or entry level employees or contract with Sheriff and Fire Departments saving est. 40% or \$3.1 million. Require that current County Retiree Positions be advertized as open positions.




LEADERSHIP: COMMISSIONER CHRIS HALL TAX CUTS

Commissioner Chris Hall has expressed his desire not to stick to "business as usual" at the county, and to look for ways to roll back or reduce taxes.

During the hearing, he reiterated that he wanted to stop the growth of what he dubs "the government monster. "Commissioners adopted the rollback rate of 3.77, a decrease from 4 mills for 2023 and 2024 taxes that cover the general fund, Conservation Collier and Pollution Control. That was possible due to property values increasing 10.33%. Commissioners Chris Hall, Rick LoCastro, Dan Kowal, William McDaniel, Jr. voted to roll back property taxes. Commissioner Burt Saunders voted

no.


