I. Legal Grounds for Mandatory Forfeiture

The FRS has a statutory duty to initiate an investigation and determine forfeiture to protect taxpayer funds, even in the absence of a criminal conviction.

The relevant law is: Florida Statute \$\S 112.3173\$ (Felonies involving breach of public trust and other specified offenses by public officers and employees; forfeiture of retirement benefits) [link: 1.1].

FRS Duty to Act: This statute mandates that the FRS must forfeit a public officer's or employee's retirement rights and privileges if the individual is:

Convicted of a specified offense. OR

Whose office or employment is terminated by reason of his or her admitted commission, aid, or abatment of a specified offense.

Application to HCSO Findings: The Hillsborough County Sheriff's Office (HCSO) internal investigations found misconduct across seven command staff members, actions that constitute a "specified offense," such as a felony committed with the willful intent to defraud the public of the right to receive the faithful performance of duty. The Sheriff's public statements and administrative actions—firing two and forcing the resignation or retirement of five others—form the basis for the mandatory forfeiture inquiry.

II. Personnel and Financial Summary

The following individuals, all members of the HCSO Command Staff, are subject to a forfeiture determination due to their separation from employment based on misconduct:

A. Academic Cheating Scandal

This misconduct involved widespread academic cheating on required coursework, resulting in a loss of public trust:

B. Illegal Gifts and "Double Dipping" Scandal

This misconduct involved working private jobs during taxpayer-paid Sheriff's Office hours and accepting illegal gifts or gratuities, a clear case of collecting taxpayer-paid salary at the same time as private work:

C. Total Taxpayer Cost of Benefits Subject to Forfeiture

All seven individuals are scheduled to receive the maximum Health Insurance Subsidy (HIS) benefit. The estimated cost of retirement benefits paid by the taxpayer for employees in the **FRS Special Risk Class** (applicable to command staff) are statutory percentages of salary, and are also subject to forfeiture:

Health Insurance Subsidy (HIS): All seven are scheduled to receive the maximum \$2,700annually (per person).

Employer Contribution (Pension/Investment Plan): approx 34.19% for Special Risk and of annual salary.

Employer Contribution (DROP): approx. 22.02% of annual salary.

Focus Case: Captain Marvin Johnson (Fired)

Captain Johnson was terminated following the internal investigation into the academic cheating scandal. As a participant in the Deferred Retirement Option Program (DROP), the following taxpayer funds are specifically subject to mandatory forfeiture:

Projected Pension Cash Bonus (DROP) Accrual (as of 2024-02-01): \$\mathbf{\\$830,983.00}\$

Projected Monthly Pension: \$\mathbf{\\\$7,359.14}\$
Projected Annual Pension: \$\mathbf{\\\$88,309.65}\$

Annual Health Insurance Subsidy (HIS): \$\mathbf{\\$2,700.00}\$

We urge the FRS to hold a public hearing and issue an order of forfeiture to ensure the funds allocated to these individuals' retirement accounts are protected and returned to the state, in compliance with Florida law.
