This letter responds to your February 2, 2026 correspondence regarding my December 4, 2025 public records request for employeelevel pension bonus (DROP accrual) information.

Your response confirms multiple violations of Florida's Public Records Act, Chapter 119, Florida Statutes, and raises additional concerns regarding the City's handling of pensionrelated documents.

1. The City's own letter admits the requested records exist and are being withheld

Your February 2 message states:

"The City is not in possession of the records... but [they] are in the possession of Foster and Foster who will be pulling them to fulfill your request."

This is a direct admission that the requested pension bonus records do exist and are held by the City's actuary on behalf of the City.

Under Florida law, records held by a contractor performing a government function are public records and must be produced promptly.

The City cannot avoid disclosure by claiming the vendor "has" the records.

This admission also contradicts the City's earlier statement that "no such records exist."

2. The City is in violation of §119.07(1)(a), Florida Statutes

Florida law requires:

"Every person who has custody of a public record shall permit the record to be inspected and copied... at any reasonable time, under reasonable conditions."

My request was submitted on December 4, 2025 — now two months ago.

Since then, the City has:

- Denied the existence of the records
- Later admitted partial records exist
- Now admits Foster & Foster holds the remaining records
- Still refuses to produce the pension bonus amounts
- Demands payment before confirming what records exist
- Failed to produce any responsive documents

This is not “reasonable time.”

This is unlawful delay and obstruction.

3. The City is misusing §119.07(4)(d) and the “extensive research” clause  
You cite §119.07(4)(d) and the Colby case to justify charging \$225.

However, the “extensive research” provision applies only when an agency must locate, review, or redact records.

It does not apply when:

- The records already exist
- The records are routinely provided to the City
- The vendor already produces the documents as part of its contract
- No redaction is required

Foster & Foster already provides the City with:

- Annual actuarial valuation reports
- DROP accrual schedules
- Employee level pension bonus data
- Documents used by HR to confirm pay, service time, and DROP changes

These are existing public records, not custom work.

Charging citizens to “compile” information the City already receives is improper and unlawful.

4. Formal demand for production of all existing pensionbonus documents

In addition to the original request, and based on your admission that Foster & Foster holds responsive records, I hereby demand the immediate production of:

All documents, spreadsheets, reports, emails, actuarial schedules, or data files sent by any vendor — including Foster & Foster — to the City of Cape Coral or its Human Resources Department that contain:

- Employeelevel DROP accrual amounts
- Employeelevel pension bonus calculations
- Pensionable pay changes
- Servicetime adjustments
- DROP entry or exit confirmations
- Any actuarial data used by HR to verify pay, benefits, or personnel changes

These documents are routinely transmitted to the City for payroll, HR, and pension administration purposes and are therefore public records.

They must be produced without delay and without charge.

5. I dispute the fee and will not pay it

For the record:

I dispute the City’s fee demand and will not pay any deposit.

The delay in producing these records is solely attributable to the City.

Until the City confirms whether it is withholding existing public records, no fee is appropriate or lawful.

6. Required written clarification

Before I determine next steps under §119.11 (judicial enforcement), please provide written answers to the following:

1. Does the City possess — directly or through Foster & Foster — any existing documents containing employeelevel DROP accrual or pension bonus amounts?
2. If yes, why have these existing records not been produced?
3. If no, is the City asserting that Foster & Foster does not provide the City with any employeelevel pension accrual data?

4. Why did the City initially claim “no such records exist” when your February 2 letter now states Foster & Foster holds them?

5. What is the legal basis for charging a fee for records that already exist and require no redaction?

6. What is the legal justification for a delay now exceeding two months?

Thank you for your correspondence. Please be advised that the City is not in possession of the records that would be responsive to this request, but are in the possession of Foster and Foster who will be pulling them to fulfil your request. Please further be advised of the City’s “Extensive” Public Records Request policy, pursuant to §119.07(4)(d), Fla. Stat. Florida public records law is clear that the City is not required to create a public record to fulfil a public records request. Further, “Florida has long required those who seek [public] records to defray the extraordinary costs associated with their requests.” *Board of County Commissioners of Highlands County v. Colby*, 976 So.2d 31, 35 (2d DCA 2008). As a result of these longstanding legal principles, the City’s policy is collect an up-front deposit of half of the estimate in order to complete your request.

This letter responds to your January 2026 notice demanding a \$225 payment for access to pension-accrual records.

I must again object to the City's handling of this request. The City's actions now constitute a violation of Florida's Sunshine Law, specifically §119.07(1)(a), Florida Statutes, which requires that public records be produced in a reasonable amount of time and prohibits agencies from delaying or obstructing access.

1. Timeline of the City's Delays and Contradictions

- December 4, 2025: I submitted a public records request for City of Cape Coral pension accrual records, including employee-level DROP accrual amounts.
- Initial City Response: "The City has reviewed their files and has determined there are no documents responsive to your request."

• Subsequent City Response: The City then produced partial retirement information, including:

- Full employee names
- Salaries
- DROP start dates
- DROP end dates

This confirms that the City does possess employee-level pension records, directly contradicting its earlier claim that no such documents exist.

Despite providing partial data, the City continues to withhold the pension bonus / DROP accrual amounts, which are part of the same actuarial records the City receives from Foster & Foster.

## 2. The City Is Withholding Existing Public Records

The City now asserts that Foster & Foster must perform “4.5 hours of research” at \$50/hour to “compile” the requested information. This is improper.

Under Florida law:

- Agencies cannot charge citizens for the creation of new records.
- Agencies cannot shift vendor labor costs to the public.
- Agencies must produce existing records, not commission new work.

Foster & Foster already provides the City with:

- Annual actuarial valuation reports
- DROP participation and accrual summaries
- Employee-level pension accrual data
- Required actuarial schedules used to administer the City’s pension plans

These are existing public records.

They are not “extensive research.”

They are not exempt.

They are not optional.

## 3. The City Is Violating §119.07(1)(a), Florida Statutes

Florida law requires:

It is not reasonable for the City to:

- First deny the existence of the records
- Then admit partial records exist
- Then demand \$225 to access the remaining portion
- Then refuse to produce the pension accrual amounts that Foster & Foster already provides to the City

This pattern constitutes unlawful delay and obstruction under the Sunshine Law.

## 4. Request for Immediate Clarification

Before I determine next steps under §119.11 (enforcement), please answer the following:

1. Does the City possess any existing documents from Foster & Foster that contain employee-level DROP accrual or pension bonus amounts?
2. If yes, why have these existing records not been produced?
3. If no, is the City asserting that Foster & Foster does not provide the City with any employee-level pension accrual data?

Please provide a written response within five business days.

5. I am not agreeing to pay the \$225 fee

Until the City confirms whether it is withholding existing records, I cannot agree to pay the fee demanded.

Ms. Bruns,

This is a second formal follow-up to my original public records request submitted December 4, 2025, and my January 21, 2026 clarification. While the City has now provided employee names, job titles, salaries, and DROP participation dates, it continues to withhold the Projected DROP Accrual / Projected DROP Payout amounts—despite clear statutory obligations to disclose non-exempt financial records.

Your initial claim that “no responsive records exist” has already been disproven by the subsequent release of DROP participation data. The City’s own DROP Activity Reports for FY23 and FY24 show annual additions, interest, and distributions—calculations that require underlying participant-level accrual data. Moreover, other Florida agencies, including Lee County Government and the Lee County School District, have routinely provided projected DROP accrual amounts dating back to 2018.

The City’s continued refusal to produce these records—now marked “SENT FOR OPINE” in the portal—appears to be a delay tactic. This obstructs public access to pension bonus data ahead of the January 31, 2026 Town Hall Meeting, where taxpayers expect transparency.

To reiterate: under Chapter 119, Florida Statutes, the City must produce all non-exempt portions of existing records. The Projected DROP Accrual / Payout amounts are not exempt under §119.071(4)(d)2., which applies only to specific personal-safety categories and does not authorize withholding pension projections.

I therefore request immediate production of:

1. Any spreadsheet, report, database extract, actuarial file, or HR/Payroll record that contains:

1. DROP Begin Date
2. Projected DROP End Date
3. Projected DROP Accrual or Payout
4. For each employee currently participating in DROP

2. If the City believes any portion of these records is exempt, please provide:

1. The specific statutory exemption for each withheld field
2. A redacted copy of the record with only the exempt information removed
3. A written explanation of the basis for each redaction, as required by §119.07(1)(d)

If the City continues to withhold these records or fails to respond promptly, I will proceed with a formal petition for enforcement under §119.11, Florida Statutes, including a request for attorney’s fees.

Time is of the essence. Please confirm whether the City intends to produce these records, claim an exemption, or continue withholding them.

Thank you for providing the redacted employee names, job descriptions, and salary information. However, the City did not provide the remaining portions of my original request—specifically:

- DROP Begin Date
- Projected DROP End Date
- Projected DROP Accrual / Projected DROP Payout

These fields were explicitly requested and are clearly maintained by the City, as evidenced by:

1. The City's own DROP Activity Reports for FY23 and FY24, which show annual additions, interest, and distributions that cannot be calculated without underlying participant-level DROP data.
2. The Active DROP Participants list you provided, which already includes names and dates—demonstrating that the City maintains participant-level DROP records.
3. The City's statutory obligation to maintain accurate pension and DROP records for actuarial, payroll, and financial reporting purposes.

Under Chapter 119, Florida Statutes, the City must produce all non-exempt portions of existing records. The DROP Begin Date, Projected End Date, and Projected Accrual are not exempt under §119.071(4)(d)2., which applies only to specific personal-safety categories and does not authorize withholding pension participation dates or projected pension payouts.

Ms. Bruns,

Thank you for your response. However, the City's assertion that "there are no documents responsive to your request" is not consistent with the City of Cape Coral's own published financial disclosures, actuarial reports, and DROP activity summaries.

The City has already acknowledged—both publicly and in writing—that:

Cape Coral employees participate in a DROP pension bonus program,

The program generates annual additions, interest, and distributions, and

The City maintains actuarial reports, DROP activity reports, and payroll/HR records that necessarily contain the names, job titles, DROP entry dates, projected DROP end dates, and projected DROP payouts for each participant.

These records cannot legally exist for accounting and actuarial purposes while simultaneously "not existing" for public records purposes.

Under Chapter 119, Florida Statutes:

A custodian may not deny the existence of records that are known to exist,

A custodian must produce any portion of a record that is not exempt, and

A custodian may not withhold records simply because they are inconvenient, sensitive, or embarrassing to disclose.

To avoid unnecessary escalation, I am giving the City an opportunity to clarify:

1. Does the City contend that no employee is currently in DROP?

2. Does the City contend that no HR, payroll, actuarial, or pension administrator maintains any list, report, spreadsheet, or database showing DROP participants?

3. Does the City contend that the Foster & Foster actuarial reports—which the City pays for—contain no participant-level DROP data?

4. Does the City contend that the City's own DROP activity reports (which I have already obtained) were created without any underlying participant-level records?

If the City maintains its position that no responsive records exist, I will proceed with the following:

Filing a formal petition for enforcement under §119.11, Florida Statutes,

Requesting attorney's fees and costs under the mandatory fee-shifting provision,

Submitting a complaint to the Office of the Attorney General,

Notifying the State Attorney for the 20th Judicial Circuit regarding potential unlawful refusal to produce public records, and

Requesting an independent review of the City's record retention and disclosure practices.

Before I initiate these steps, I request a final confirmation from the City as to whether it intends to:

Produce the existing records,

Claim an exemption, or

Continue asserting that no responsive records exist.

Please respond within five business days so that I may determine the appropriate next action.
